

St Marie's School, A Catholic Voluntary Academy Safeguarding Children Contacts

We all have a statutory duty to “safeguard and promote the welfare of children”.

If you have any concerns about the health and safety of a child at this setting or feel that something may be troubling them, you should share this information with an appropriate member of staff straight away. Some issues e.g. a child's appearance, hygiene, general behaviour, can be shared with any teacher or member of support staff here.

Do not worry that you may be reporting small matters – we would rather that you tell us things which turn out to be small than miss a worrying situation.

However, if you think the matter is very serious and may be related to a child protection concern, e.g. physical, sexual, emotional abuse or neglect, you must talk to the people below immediately. If you are unable to contact them you can ask the office staff to find them and ask them to speak to you straight away about a confidential and urgent matter.

Any allegation or disclosure involving someone who works with children in a paid or voluntary capacity **must** be reported directly to the Head, unless it involves the Head and then it should be reported directly to the Chair of the Governing Body.

Looked after children (LAC) designated teacher**

Responsible for:

- Implementing policies and procedures
- Allocating resources within the safeguarding team
- Addressing staff safeguarding concerns
- Dealing with safeguarding issues
- Providing advice and support to other staff
- Liaising with the local authority
- Working with other agencies
- Promoting the educational achievement of 'looked after' children

Alison Fenton: Designated Safeguarding Deputy (DSD) and E-Safety Co-ordinator

Responsible for:

- Deputising for the DSL, in his absence
- Carrying out roles as above when deputising, and as part of the team
- Develops and maintains an e-safe culture within a setting
- Dealing with specific issues that may be delegated to him

Kath Hanson: Assistant Safeguarding Liaison Officer & Learning Mentor

Responsible for:

- Dealing with safeguarding issues
- Addresses difficulties preventing a child from reaching their full potential, e.g. behaviour, attendance, achievement, timekeeping, homework, and develops strategies to overcome these barriers
- Working with other agencies, particularly with relation to Special Educational Needs

Maria Fernandes: SENCO (special Educational Needs Co-ordinator)

Responsible for:

- Providing advice, liaison and support for school staff and other agencies working with pupils with special educational needs and their parents and carers.
